The Bethany Pre and Primary English Medium School in Kisongo, Tanzania added Grade 7 and grew to about 500 students. The first 7th grade graduation was held in September. New textbooks were purchased to remain in compliance with government standards. A pallet of 16 large tables was purchased in the USA and shipped to Tanzania. A new headmaster was hired to improve teaching standards. Many tubs of supplies not readily available in Tanzania were shipped to the school from the USA.
